

Whereas Sh. Ved Parkash & others filed CWP No. 15643 of 2012, in the Hon'ble High Court Punjab & Haryana, for quashing the order dated 30.07.2012 passed by Director-Principal, Chaudhary Devi Lal Memorial Government Engineering College, Panniwala-Motta, (Sirsa), vide which teaching work of Practical and Workshop was counted as half while calculating the teaching work load, in supersession of all previous orders/instructions, in this regard. The Hon'ble High Court vide order dated 28.09.2012 directed the respondent No. 4 to consider and decide the representation dated 01.08.2012 submitted by the petitioners (Annexure P-7).

In compliance of the above said order of the Hon'ble High Court, Annexure P-7 was examined thoroughly, and after consideration of the issue regarding counting of the workload of practicals and workshop while calculating the teaching workload of faculty, was reconsidered in the light of AICTE instruction and the Norms followed by the affiliating university i.e. Guru Jambheshwar University of Science & Technology, Hisar. After reconsideration it is decided that it would be appropriate in the interest of Justice to withdraw the order of Director-Principal Chaudhary Devi Lal Memorial Government Engineering College, Panniwala-Motta, Sirsa order no. CDLMGEC/2012/109 dated 30.07.2012. Accordingly Director-Principal of Chaudhary Devi Lal Memorial Government Engineering College, Panniwala-Motta, Sirsa, is hereby directed to withdraw the same with immediate effect and issue a fresh order clarifying the Unit allocation Mechanism as per regulation of the University to which the Institute is affiliated i.e. Guru Jambheshwar University of Science & Technology, Hisar.

The representation is accordingly disposed off.
