Regarding adoption of various recommendations of the UGC & MHRD with regard to minimum qualifications for appointment of teachers and other academic staff in the Universities and Colleges and measures for the maintenance of the standards of Higher Education.

Kindly refer to the subject noted above.

In this regard, it is intimated that the State Govt. has considered the recommendations of the committee constituted for adoption of various regulations of UGC notification of Revised Pay Scales / Career Advancement Scheme in respect of University and Colleges under the Deptt. of Technical Education and decided as under:-

1. The Clause 9.0 'Career Advancement Scheme' may be amended as under:-

The new Career Advancement Scheme shall be effective prospectively i.e. from the date of notification. Provided that in the event any candidate becomes eligible for promotion under Career Advancement Scheme in terms of these regulations on or after date of notification, the promotion of such candidate shall be governed by the provisions of these regulations. Provided further that the candidates who become eligible for promotion under Career Advancement Scheme during the period from 01.09.2009 to date of notification their cases shall be governed by the provisions of the existing scheme as per notification dated 08.12.2000 and their pay shall be fixed in accordance with Finance Department notification dated 20.08.2009, 27.8.2009.

Provided further that the Associate Professor completing three years of service in Stage 4 (Pay Band-IV with AGP Rs. 9000) and possessing a Ph.D. Degree in the relevant discipline before the date of notification i.e. 21st July, 2011 shall also be eligible to be appointed and designated as Professor and be placed in the next higher grade Stage-5 (pay Band-IV) with AGP Rs. 10000), subject to (a) satisfying the required credit points as per API based PBAS methodology provided in Table I-III of Appendix IV stipulated in these Regulations, and (b) an assessment by a duly constituted selection committee as

suggested for the direct recruitment of Professor. Provided that no teacher, other than those with a Ph. D., shall be promoted or appointed as Professor. The pay shall be fixed in accordance with Finance Department notification dated 20.08.2009, 27.08.2009 and 02.09.2009.

2. Entry level pay of directly recruited Associate Professor in Universities appointed before this notification, may be granted Rs. 22320/- in Pay Band-3 with AGP of Rs. 8000/- notionally w.e.f. 1.1.2006 and actually from the date of notification of Higher Education Department, i.e. 21/07/2011.
