Sir,

I am directed to inform you that extension in Provisional Affiliation to Ch. Devi Lal State Institute of Engineering & Technology, Panniwala Motta, Sirsa. for B.Tech. (Civil, CSE, EE, ECE, ME) with an intake of 60 seats for each programme for the Academic Session 2019-20 has been granted by the Vice-Chancellor subject to the fulfilment/removal of the following conditions/deficiencies pointed out by the inspection committee of the University and AICTE due course of time:

1. To initiate the process through State Govt. for recruitment of faculty and procurement of equipment for various labs for the compliance of conditions imposed by the University.
2. Situation has not changed on both the points raised in the letter of grant of extension of provisional affiliation 2018-19.
3. ECE and ME Departments are using open source software wherever required.
4. Instituted is following scheme and syllabi of the affiliating University.
5. B.Tech. Food Technology has been closed by AICTE for Academic Year 2019-20. Faculty has expressed their concern either to review the decision of closure of B.Tech. Food Technology programme or to adjust all of them in any of the Technical University/Engineering Institute of the State. Further, because of availability of adequate infrastructure and qualified faculty at Institute, the committee is also of the view that their concern be resolved at the earliest.
6. Fulfillment of required number of faculty and equipment in each lab as per scheme and syllabi of affiliating university to run all B.Tech. Programmes.
