1. A special concession of Rs. 3000/- may be allowed to SC/ST/PwD/ESW students for special examination chance (September-2025). Such students have to pay Rs. 5000/- instead of Rs. 8000/-.
2. The concession fee of Rs. 3000/- already deposited by such students will be refunded.
3. The examination form will be received through online mode only. However, students roll number series/registration started before 2017 can apply through offline mode.
4. No examination form(s) will be entertained after the last date in any circumstances.
